SUBJECT: Financial responsibility for out-of-province operators

PURPOSE OF CIRCULAR

To advise that effective immediately, out-of-province operators are not required to carry documentary proof that financial responsibility (FR) has been filed with ICBC. FR numbers issued by ICBC may be accepted as proof of FR and verified by CVSE electronically. If the operator does not know the FR number, a filing may be verified electronically by carrier name.

BACKGROUND

The *Motor Vehicle Act* requires out-of-province commercial vehicles to be insured to BC minimum insurance requirements. Vehicle owners or lessees can meet these requirements by having their insurance company file a *Financial Responsibility Certificate* with ICBC. The Certificate is a guarantee of third party liability insurance that meets BC requirements and covers all vehicles owned and operated and/or leased and operated in the name of the insured.

If FR has not been filed with ICBC, out-of-province operators must purchase ICBC Basic insurance sold in conjunction with a Non-Resident Commercial Permit.

Prior to this notice, ICBC notified carriers by mail when their FR filing was approved. Notification included an FR number to be carried in the vehicle(s) as proof of insurance. Carriers have reported that the current paper-based process is slow and cumbersome to administer. ICBC has made procedural changes to improve efficiencies and ease of compliance for carriers.

APPLICATION

Effective immediately, out-of-province operators may quote the FR number issued by ICBC as proof that BC insurance requirements have been met. The FR number can be validated electronically by weigh scales, the Provincial Permit Centre, and roadside enforcement. FR filings may also be validated electronically by name of vehicle owner or lessee (the carrier that filed FR with ICBC).
