PROGRAM INFORMATION

Clean Energy Vehicles displaying a permit issued by the Ministry of Transportation and Infrastructure are exempt from meeting the occupancy requirements of high occupancy vehicle (HOV) lanes in British Columbia, unless a sign is posted indicating otherwise.

Vehicle Eligibility:

An eligible EV has an electric propulsion motor and a battery storage system which can be charged from an external source (i.e. plugged into an electric charging outlet). The vehicle make, model and year described in your application and appearing on the vehicle registration will be checked against the eligible vehicle list to confirm eligibility. Conversions are ineligible.
