

## 2016 TLCI Request for Taxis

### About this Form

Use this form if you are a taxi licensee that wants a 2016 Taxi and Limousine Cost Index (TLCI) rate increase of up to 2.9%.

In the Metro Vancouver and Fraser Valley common rates areas, licensees with 51% of the taxis must request an increase for it to be applied to all licensees in the area. In other common rates areas, at least 51% of licensees must request an increase.

The **final deadline** for requesting a 2016 TLCI increase is **September 30, 2016**. See [www.ptboard.bc.ca/tci.htm](http://www.ptboard.bc.ca/tci.htm) for details.
