Record Review Application Overview

If you are disqualified from being a driver of a passenger directed vehicle, you can submit a Record Review Application to the Registrar of Passenger Transportation (the Registrar). The application can be submitted if a company with a passenger transportation licence (the licensee) does not issue you a record check certificate or you give notice to the licensee upon acquiring a record with a "prescribed matter" as defined in <u>section 12.6(1) of the Passenger Transportation Regulation</u>.

The application must be submitted to the Registrar within 30 days of the licensee notifying you that the record check certificate cannot be issued, or you provide notice to the licensee if you acquire a record between record checks. If the application is received after the 30 days, it may not be reviewed. There is no fee for this application.

The review process may require you to submit additional information for the Registrar's review. If applicants do not provide the requested information by the specified date, the application will be processed as is. The Registrar's decision of the record review and reasons will be sent to the applicant and licensee. All communication will be sent in writing.

Additional Information

In the application, you must include a copy of the results of your police and driving record check for review. You must also provide supporting documentation that is relevant to your review. The Registrar will make a decision based on the information that you provide. It is important to set out all the relevant details and include all documents that support why you think the matter is not a prescribed matter or if it is, why you believe that the matter is unrelated to your work or intended work as a driver of a passenger directed vehicle. This will ensure the application is not delayed.
