#### Submissions for Application Hearings:

Any person, including those who may have made a previous submission or objection, wishing to make a submission at this hearing must follow the steps below.

Any person wishing to make a submission, within 21 days of the date that this notice is published in the PT Board Bulletin:

- pay to the board a fee of \$50 and
- provide to the board and applicant a written summary of the assertions and evidence that the submitter intends to present at a hearing
- provide proof of service documents referred to in subparagraph (b) above, at the request of the board.

If the board does not receive any requests for submissions, the board may order that an oral hearing be discontinued, and conducted via another means, such as in writing or by teleconference.

The Board may hold a pre-hearing conference into the application and may determine the date and time of such a conference.

The Board will provide the applicant and submitters with more information about hearing processes, once all submitters have been identified.
