2008 PDV Fleet Size Review Outcomes

Under section 31(4) of the Passenger Transportation Act, the Board may review the maximum fleet size set out in the authorizations to operate passenger directed vehicles (PDVs). On October 21, 2008, the Board completed its first review of maximum fleet sizes of companies with special authorization to operate PDVs.

PDV fleet size reviews are limited to those companies that have been operating below the maximum allowable fleet size for at least 2 consecutive years. When a review is conducted, the maximum fleet size may remain unchanged, or the Board may reduce the maximum fleet size to reflect actual or planned levels of operation. In 2008, the Board reduced the maximum fleet size for the licensees or applicants listed below. In cases where the maximum fleet size has been reduced to zero, the Board's special authorization to operate passenger directed vehicles has effectively been nullified.
