### Taxi Surveys

The Board mailed two surveys to taxi licensees last week. One seeks licensee input on how the Taxi Cost Index is administered in British Columbia. The other seeks input from licensees serving areas with more than 60,000 people about how they collect and use data for the trips they provide. Licensees are asked to complete and return the surveys by May 4, 2012.
