Submissions will be forwarded to applicants. If you say that you are submitting on specific applications, your submission will be provided only to those applicants. If you say that you are commenting on all applications, your submission will go to each applicant. If you do not specify any applications, your submission may go to each applicant.

You must pay **1 submission fee of \$50** to make a submission on one or more of these applications. (Note: you do not have to pay \$50 for each submission.)
