- Friday/Saturday and Saturday/Sunday from 10:00 p.m. – 05:00 a.m. between February 7 and August 31, 2014
- From 6:00 am to the following morning at 6:00 am on May 9, 16, 17 and 24, 2014
- From 5:00 pm July 30, 2014 to 4:00 am on July 31, 2014

The Board has considered the applications at the same time and issued one decision.
