Limousine Regulation Change: Perimeter Seating Buses

Limousines with primarily perimeter seating – regardless of seating capacity –now require a Special Authorization licence. General Authorization licensees operating stretch limousines or limo buses must have a Special Authorization licence by **May 1, 2015** if they want to continue operating these vehicles.
