## 1. Industry Updates & Advisories

### New Licensing Requirements for Perimeter Seating Buses take effect May 1, 2015.

Stretch limousines and limo buses that seat 12 or more passengers (perimeter seating buses or PSBs) cannot be operated under a General Authorization licence after April 30, 2015. Application packages are posted on the Board's [web page for PSBs](#).

### Rates for PSBs and Limousines

[This advisory](#) sets out policies and principles that will guide Board decisions respecting PSB rates. It also advises that the Board will, in early summer, survey limousine licensees in the Vancouver and Victoria areas about rates charged by limousine operators (including PSB operators).
