## 1. Industry Updates & Advisories

### Taxi Camera Equipment Review

The Board has [announced](#) the outcome of its taxi camera equipment review. In brief:

- Two VerifEye G6 taxi camera models are approved for use in BC.
- Licensees must replace VerifEye G5 camera heads by upcoming deadlines.

### New Licensing Requirements for Perimeter Seating Buses take effect May 1, 2015.

Stretch limousines and limo buses that seat 12 or more passengers (perimeter seating buses or PSBs) cannot be operated under a General Authorization licence after April 30, 2015. Application packages are posted on the Board's [web page for PSBs](#).
