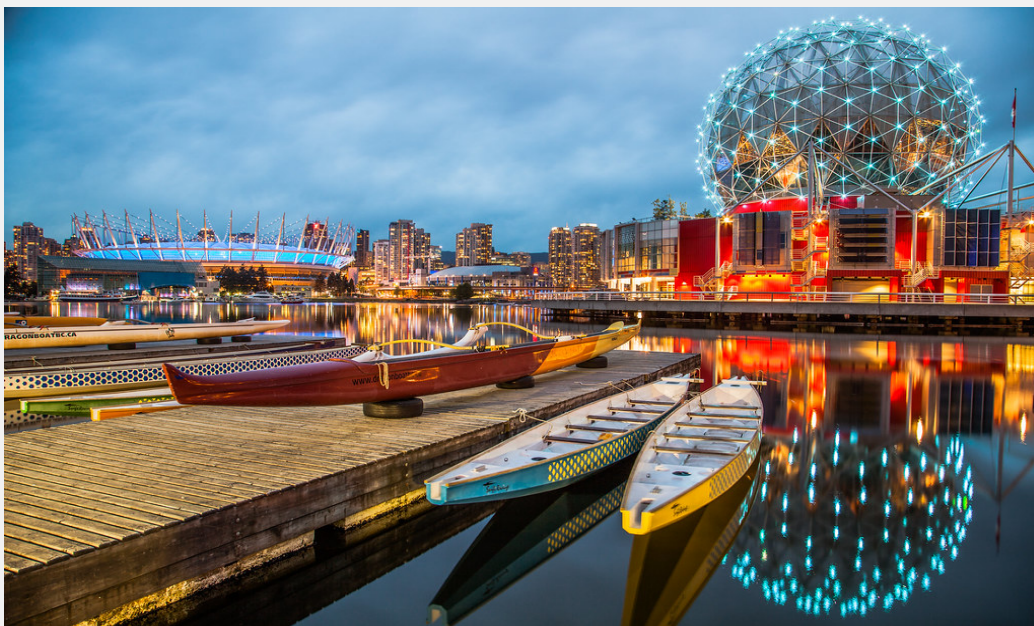


Passenger Transportation Board **Weekly Bulletin**
