

# Board Rule

<b>Subject</b>	<b><i>Mandatory Use of Taxi Cameras in the Lower Mainland</i></b>
<b>Legislation</b>	Passenger Transportation Act section 28(2):  <i>If the Board approves in whole or in part, an application forwarded to it under section 26(1), the board may establish the terms and conditions that are to apply to the licence if issued.</i>
<b>Purpose</b>	To continue and enhance the taxi camera program in the Lower Mainland for taxi driver and passenger safety.
<b>Context</b>	A taxi camera program was established in the Lower Mainland on June 15, 2005. After a stakeholder review of the program, and as recommended by the review group, the Board issued a rule on November 4, 2008, that required an upgrade for all original taxi camera models (ie. Honeywell Fareview FV128 and VerifEye MK IV Rev. D, each with a single camera).  Further to the Board's decision on application T246-09, Aldergrove Langley Taxi Ltd. must have a taxi camera installed in each of its taxicabs by July 16, 2010.
<b>Rule</b>	<ol style="list-style-type: none"><li>1. All Lower Mainland taxicab licensees, with the exception of Aldergrove Langley Taxi Ltd., must have an approved taxi camera installed and operating in each taxicab. Aldergrove Langley Taxi Ltd. must have an approved taxi camera installed and operating in each taxicab <b>no later than July 16, 2010</b>.</li><li>2. Lower Mainland licensees must adhere to the standards and requirements set out in the Board Rule, <i>BC Taxi Camera Programs, Standards &amp; Requirements</i>.</li><li>3. The only taxi camera <b>approved for installation</b> in a Lower Mainland taxicab is:<ol style="list-style-type: none"><li>a. <b>VerifEye MKIV Rev. G ("G5" Dual Cam) w/ 2GB memory / Pre-alarm</b></li></ol></li><li>4. The following taxi cameras are <b>approved for use</b> in a Lower Mainland taxicab:<ol style="list-style-type: none"><li>a. <b>VerifEye MKIV Rev. G ("G5" Dual Cam) w/ 2GB memory / Pre-alarm</b></li><li>b. <b>VerifEye MKIV Rev. G ("G4" Dual Cam) w/ 2GB memory / Pre-alarm</b> (only if installed prior to November 4, 2008).</li></ol></li></ol>
<b>Applicability:</b>	This rule applies to all taxicab licensees in the Lower Mainland. See Appendix A for a list of licensees.
<b>Former Rules:</b>	The Board Rule, <i>Mandatory Use of Taxi Cameras in the Lower Mainland</i> , effective November 4, 2008, is rescinded and replaced by this rule.
<b>Effective Date</b>	<b>January 16, 2010</b>
