Information Requirements – Application for Addition of ICB Motor Vehicle(s) – Form PT5023

Basic Information Requirements

- a) Special Authorization Application Form for Addition of Inter-City Bus Motor Vehicle(s) (Form PT5023) is included in this application package.
- b) Brief description of the type, model and passenger carrying capacity (excluding the driver) of the proposed vehicle(s) to be utilized.
- c) Signing Authority (Form PT5002)

This requirement is not applicable if there are no changes to your Signing Authority Form on file with the Branch.

If there are changes to the Signing Authority form you have on file with the Branch, blank forms are available on the Registrar's web site http://www.th.gov.bc.ca/rpt or by contacting the Passenger Transportation Branch at (604) 453-4250 or toll free at (888) 453-4280.

Vehicle(s) Information

The filing of an application does not confer any permission or authority to operate the additional ICB motor vehicle(s) under your Special Authorization Licence. Applicants are advised to delay the purchase or lease of vehicles until approval is obtained from the Registrar of Passenger Transportation.

Before identifier(s) (plate and decal) can be issued the Branch will contact you to request that you submit the required vehicle(s) documents and identifier (plate and decal) fees.

If vehicles have been purchased, you have included:

Vehicle(s) base plated in BC

- a) \$100 for each identifier (plate and decal) requested (cheques, money orders, Visa and MasterCard payable to the Minister of Finance, in Canadian funds only, are accepted)
- b) Photocopy(ies) of current vehicle registration(s) "Owner's Certificate(s) of Insurance and Licence/Vehicle Registration" that:
 - i) show the vehicle(s) to be licensed/registered in the correct I.C.B.C. insurance category;
 - ii) show the vehicle(s) to be classified as "commercial type"; and
 - iii) display the correct seating capacity.
- c) Photocopy(ies) of the Commercial Vehicle Inspection Report(s) (CVIP), Form MV3104, that verify the vehicle(s) have been inspected and passed by an approved vehicle inspection facility (Please note, inspections are required to be performed on a semi-annual basis unless your operation is part of a preventative maintenance program).

Vehicle(s) base plated outside of BC

- a) \$100 for each identifier (plate and decal) requested (cheques, money orders, Visa and MasterCard payable to the Minister of Finance, in Canadian funds only, are accepted)
- b) Photocopy(ies) of current vehicle insurance showing the vehicle(s) have been properly licensed, insured as commercial passenger vehicles and displaying the correct seating capacity.
- c) Photocopy(ies) of mechanical inspection report(s) that verify the vehicle(s) have been inspected and passed by an approved vehicle inspection facility. (Please note that semi-annual inspections are a requirement in BC).
- d) You have entered your <u>British Columbia Financial Responsibility Certificate (BC Insurance Filing)</u> number on your application form, in the space provided in Section 2, if your vehicle(s) are base plated outside of British Columbia and you hold a valid BC Insurance Filing letter issued by the Insurance Corporation of British Columbia (ICBC); **OR**

If you do not have a BC Insurance Filing number, you have included a written explanation on how you are intending to meet your motor vehicle liability insurance requirements (e.g. you will purchase a non-resident single commercial vehicle permit (NRSCV) or a non-resident quarterly commercial vehicle permit (NRQCV), that includes an insurance certificate, from the Provincial Permit Center's toll-free vehicle permit line: 1-800-559-9688 or at an inspection station, formerly known as a weigh scale, when entering British Columbia).

e) If vehicle(s) have been purchased or leased, and are base plated outside of British Columbia, you have included a copy of your apportioned cab card showing proof that your vehicle is registered in British Columbia with the <u>International Registration Plan (IRP)</u>; **OR**

If you are not registered with IRP, you have included a written explanation on how you are intending to pay your British Columbia vehicle licensing fees (e.g. you will purchase a non-resident single commercial vehicle permit (NRSCV) or a non-resident quarterly commercial vehicle permit (NRQCV) from the Provincial Permit Center's toll-free vehicle permit line: 1-800-559-9688 or at an inspection station, formerly known as a weigh scale, when entering British Columbia).
