General Information about Change of Rates (PDVs)

Applications to change rates and rules may be considered in light of applicable, current Board rules respecting PDV rates. This includes rules respecting such matters as the Taxi Cost Index (TCI) or a rate surcharge that may be in effect.

Taxi Cost Index and Surcharges

At times, the Board establishes rules and processes for rate increases (such as a Taxi Cost Index or Temporary Fuel Surcharge) for certain PDVs that do not involve a Change of Rates application under section 35 of the Passenger Transportation Act. The requirements set out in those rules will apply, not the requirements that apply to Change of Rates and Rules applications.

Application Filing Fee

The application filing fee for a Change of Rates and Rules application is \$200 and is non-refundable once an application is accepted by the Passenger Transportation Branch.

The filing fee is payable to the Minister of Finance (Canadian funds only) by cheque, money order, Visa or MasterCard (a credit card remittance slip is included in this application package).

Applications received without submission of the filing fee will be returned, unprocessed, to the applicant.

Application Requirements

Registrar of Passenger Transportation Application Requirements:

- a) Application to Change Rates and Rules application form (Form PT5026)
- b) Application Filing Fee
- c) Signing Authority (Form PT5002)

This requirement is not applicable if there are no changes to your Signing Authority Form on file with the Branch.
