#### RECORD CHECK REVIEW APPLICATION OVERVIEW

Record Check Review Applications may be submitted to the Registrar of Passenger Transportation (the Registrar) by applicants who, within the prior 30 days, have been denied a record check certificate by a Passenger Transportation licensee, or the applicant has returned their record check certificate and given notice to a licensee, based upon acquiring a record with a prescribed matter as defined in section 12.6(1) of the Passenger Transportation Regulation.

Applications received after the 30 days will not be accepted for review.

The Registrar's written decision will be sent to both the applicant and licensee.

There is no fee for this application.

#### **PROCESS INFORMATION**

In addition to this form, applications include:

- A dated copy of the written notification from the licensee indicating they are unable to issue a record check certificate to the applicant, or the dated notice provided to the licensee by the applicant of a record with prescribed matter
- Current police information check with vulnerable sector screening (PIC-VS)
- Current commercial driver's abstract ("N print"), available from ICBC
  - If the applicant has not been licensed in British Columbia for the last 3 continuous years, the applicant must also provide a driving record check obtained from the agency or entity that issued the applicant a driver's licence in that jurisdiction
- Any documentation relevant to the review that supports why the prescribed matter on the driving/police record check is not a prescribed matter and/or is unrelated to driving a Passenger Directed Vehicle (PDV).

The application should include all relevant details and documents that show why the applicant has no prescribed matters, or why the matters are unrelated to driving a PDV. Submitting a complete application ensures the application is not delayed.

The Registrar will determine (as applicable):


- i. Whether the record includes a matter under section 12.63 or section 12.66 of the Passenger Transportation Regulation
- ii. Whether the matter is unrelated to driving a PDV and, for this purpose, the Registrar must consider public safety The Registrar will notify the applicant and the licensee in writing of the determination.

### **LEGISLATION AND REGULATIONS**

The legislation and regulation referred to in this application package are subject to amendment and judicial interpretation.
