- New applicants who are applying to operate a taxi or limousine in any part of the Greater Vancouver Regional District or the Squamish-Lillooet Regional District
- Taxi or limousine licensees who are applying to transfer or amend their licence or add vehicles to their fleet and who operate in any parts of the Greater Vancouver Regional District or the Squamish-Lillooet Regional District

For all other applications, the submission period remains the same

5. Other Matters

Temporary increase in YVR limousine zone rates (632226 BC Ltd. / Aerocar).

A [Board Rule](#) is now in effect respecting minimum and maximum hourly rates for limousines during the 2010 Games. Licensee 632226 BC Ltd. (doing business as "Aerocar") requested a temporary increase in its zone rates. The Board rule for limousines that charge hourly rates does not apply to the per trip zone rates charged by Aerocar for limousine transfers at the Vancouver International Airport (YVR). The Board approved a temporary increase in the Aerocar YVR zone rates for the period January 24, 2010 until March 24, 2010.
