## Applications from 4 Vancouver Taxi Companies

The Board received similar applications from 4 Vancouver taxi companies. The companies are applying to add collectively 99 additional vehicles to their fleets. The vehicles would also operate on “black” and “red” days at cruise ship terminals as established each year by the Vancouver Port Authority.
